## 2008 Annual Dive Trip May 16 - May 24, 2008



Join us for the annual Sea Stallion dive trip. Our destination for 2008 is the island of **Bimini** in the **Bahamas**. We will be staying at the **Bimini Big Game Resort**. Bimini is known for excellent diving and offer a good opportunity to observe a diverse marine life and swim with wild dolphins.

### The Resort

The **Bimini Big Game Resort** enjoys the best location on the island. All the attractions of Alice Town, the Bimini Museum, and the Straw Market are just minutes away on foot. A beach, perfect for swimming, is also just a short stroll away.

### The Diving

Dive sites in Bimini range from shallow reefs and wrecks to walls dropping into the abyss of the Gulfstream waters. The corals are healthy and vibrant. It's not uncommon for visitors to see wild spotted dolphin, loggerhead turtles, southern stingrays, large groupers, reef sharks, nurse sharks, and barracudas, along with many tropical fish and critters.

### The Trip Package
